2005 Annual General Meeting

Report on the 2005 Annual General Meeting

This year's AGM was held on 23rd April 2005 at the Eastin Hotel, Petaling Jaya, Selangor Darul Eshan. The President called the meeting to order at 5.15pm. 28 members attended the meeting. The notice and agenda for the meeting were circulated to all members in a Notice dated 14th March 2005. The meeting began with the confirmation of the minutes of the previous AGM.

The President presented his Presidential Address, which was requested by members in the previous AGM. He highlighted the draft roadmap of the future strategies of the Society. He expressed his personal interest to upgrade the Society's Bulletin to be an Institute of Scientific Information (ISI) journal.

The Secretary presented the Secretary's Report by highlighting that the report also try to give credit to those volunteers who have helped to run the Society in one way or another. He also stressed on Awards and Recognition. There are various things that need immediate attention, such as the decreasing numbers of members, especially student members, the decreasing participants in events or technical talks, especially those delivered by well known geoscientists, and no field trip has been organized by the Society of late.

In the absence of the Editor and the Assistant Secretary, the Secretary read out the Assistant Secretary's Report and Editor's Report. The Society's newsletter, *Warta Geologi* is current for the year. As highlighted by the President, in order to be an ISI journal, our Bulletin must also be published on schedule. There is a bright future for the Society's publications.

The Treasurer presented the Treasurer's Report and the Honorary Auditor's Report. He highlighted that the Society posted a financial surplus compared to a deficit in the previous year. The operating revenue was increased by 84% while total operating expenditure was tremendously decreased. Hopefully, we can see the rebirth of GSM as a financially viable organization, as the Society's financial status went through a positive metamorphosis.

The Secretary read the proposed amendments by the Council on the Constitution (Article III: Membership, Section 1 and 5) and By-Law (By-Law 1: Dues, Section 2 and 3). Ballot will be carried out as soon as possible after the AGM.

The existing Honorary Auditor, S&F Lee & Co. was reelected for the year 2005/2006. No other matter was discussed, as the member who requested to discuss the matter pertaining to publication archives was absent.

The meeting ended with the announcement of new Council for 2005/2006 by the President and the list of the new Council is presented in the full report. The meeting ended at 6.50pm.

It was noted that there was enough quorum for the meeting. The President welcomed the members who were present at the AGM.

1. Confirmation of the Minutes of the Previous AGM (2003)

The Minutes of the 37th AGM (2003) were proposed by Paramnathan S. and seconded by Lau Yin Leong to be confirmed with the following amendments:-

Page 3, Secretary's Report, para 4 should be read as follows: "An EGM was called and held on 28/10/02 to discuss about the sacking of the Editor and editorial matters but it was aborted due to some technicalities in its requisition."

2. Matters Arising

- i) Secretary's Report
The aborted EGM to be minuted in a little more detail.
- ii) Editor's Report
Bulletin 40 has been published and sent out.
- iii) Treasurer's and Honorary Auditor's Report
The Treasurer to keep a Registry/Inventory of Plant and Equipment listing in detail all the assets of the Society and where the assets are kept.

3. President's Report

The President reported to the meeting about the Society's activities in particular the 2003 Annual Geological Conference in Kuching, Sarawak; COSTAM's Science and Technology Congress whereby our Immediate Past President, Prof. Dr. Ibrahim Komoo delivered a keynote address; the Geophysics Seminar in collaboration with the Geology Department, University of Malaya; and the Petroleum Geology Conference and Exhibition in Kuala Lumpur.

The meeting noted that the President's and Secretary's Reports overlap and directed that the next President's Report should be a Presidential Address instead. In his address, the next President should highlight the Society's achievements, networking and the future of the Society.

The President's Report was proposed by Paramnathan S. and seconded by Loganathan S. to be accepted.

4. Secretary's Report

The Assistant Secretary acting in the position of Secretary reported that the 2003/2004 session began on a bright note with the go-ahead for the 2003 Annual Geological Conference despite the threat of SARS. Then, crisis struck the Council with the resignation of the Secretary but the Council plodded along and ended the year with a flourish with a well-attended Petroleum Geology Conference & Exhibition where there were 521 participants. In between the two core activities of the Society, 4 seminars, 9 technical talks, a Chairman's Lecture and a Forum were organised. After the counting of the votes for the President's and Editor's posts for the 2004/2005 session, the President did not sit out his term and tendered his resignation. The Vice President assumed the position of President after the Council accepted the resignation so as to put the Society back on track.

The Assistant Secretary also reported that at the last AGM, there was a proposal to redefine the Society and the Council formed a task force under the leadership of Dr KK Liew to undertake the project. This resulted in the development of a permanent website for the Society. The members were updated on the Redefinition of GSM at an EGM called on 10/1/04.

The members were also informed that the 2004 Annual Geological Conference will be held in Kangar, Perlis in June; and a Geophysics Seminar organised together with MINT will be held in Bangi in August.

The Assistant Secretary voiced the Council's acknowledgement of thanks to all individuals and organisations (members and/or non-members) that have helped in one way or another in the organising of the Society's activities during the 2003/2004 session.

The meeting brought up matters concerning the website's contents, updates, hosting, and space capacity. Dr. KK Liew and Lim Chee Kheong (webmaster) informed that all elements of the website have been carefully looked into and reported to the members at the EGM. A Website working group has been formed and accepted by the Council.

It was brought to the meeting's attention that in Appendix 1, some Council Members were not present for many Council meetings. It was proposed that a letter be written to Council Members who were absent for three consecutive Council meetings without valid reasons to show cause why they should not be dropped. The point had been noted and the new Secretary will take appropriate action.

The Secretary's Report was proposed by Loganathan S. and seconded by Sia Hok Kiang to be accepted.

5. Editor's Report

In the absence of the Editor to present his report, the President referred the meeting to the Editor's Report in the Annual Report highlighting that all backlogged Bulletins and Wartas were brought up-to-date.

The meeting pointed out the high printing expenditure as shown in the financial figures for Year 2003 and directed the Council to look into ways to cut-down on the cost of printing including the publishing of the Bulletin in CD format instead of hardcopies.

The meeting also directed the Council to endorse all contents of the Bulletins and Wartas before publication to avert potentially undesirable situations as per the report in the Warta about the aborted EGM called on 28/10/02. The Editor should present the contents of the publications to the Council before publishing.

The in-coming Editor, Dr. KK Liew remarked that he would present printing quotations, publication content, budgets to the Council for approval.

The Editor's Report was proposed by Abd Rasid Jaapar and seconded by Abd Hanan b Ahmad Nadzri to be accepted.

6. Treasurer's and Honorary Auditor's Report

The Treasurer reported that there will be a change in the accounting "habits" of the Society. As a start, the Honorary Auditor's Report has been expanded to make it into a proper report.

He also reported that all future activities will have to be properly budgeted to spend less, and funds for activities to be sourced from sponsors/donors citing the AGC and Geophysics Seminar as examples.

He also reported that in order for the PGCE to be more profitable, the Council should give its full support to the organising committee.

He also planned to sell the Society's publications through promotion in the Society's website.

The meeting congratulated the Treasurer's more professional approach to the financial matters of the Society.

The Treasurer clarified that the income of RM121,702 for the PGCE was a nett income, as expenses for the PGCE were borne by sponsors.

The meeting directed the Council to formulate a publication policy inclusive of cost (and content) to minimise expenditure in printing after discussion on the various suggestions by the members.

The Treasurer's and Honorary Auditor's Report was proposed by Paramnanthan S. and seconded by Sia Hok Kiang to be accepted.

7. Election of Honorary Auditor

On the proposal by Fateh Chand and seconded by Choo Mun Keong, the meeting agreed to elect S.F. Lee & Co as the Honorary Auditor for Year 2004.

8. Other Matters

- i) On the matter brought up by Chin Lik Suan, the Council on behalf of the Society acknowledges a vote of thanks to the late Jimmy Khoo as Organising Chairman of the AGC 1996 in Kota Kinabalu and the papers presented thereof were published in Bulletin 40.
- ii) On the matter of quorum for meetings especially the AGM brought up by Choo Mun Keong, the meeting agreed that not only the quorum part of the Constitution will be looked into but the whole Constitution of the Society will be reviewed. A committee should be formed to review the Society's Constitution (3 months), recommend to the Council, call for an EGM (1 month), and conduct a postal ballot (2 months) to approve the revised Constitution. The appropriate authorities will then be duly informed.

President's Report 2004

I would like to begin by thanking all of you and especially my fellow council members and members of the various organising committees and working groups for your support during this past year. Many of you have gone beyond the call of duty to go the extra mile to run the activities of the Society.

I am particularly impressed by the three part series on issues in the redefinition of GSM done by our enthusiastic and hard working Secretary. We may not agree with all his opinions but we should thank him for the effort. If you have read his articles, you would have realised the truth of what he said about the danger of complacency leading to blind spots, poor quality, excessiveness, inaction, strategic vulnerabilities and deteriorating bottom line performance. I am happy that he did not just stop at pointing out the potential dangers faced by the society but also suggested ways to overcome them based on our strengths, resources and past experience guided by our vision, mission and values as spelt out at the EGM on Redefinition of the GSM last year. Various strategic activities and improvements to our structure were suggested to enable us to be more effective and efficient. His SWOT analysis of GSM concerning its publications, membership, activities and participation, financial and asset management is laudable.

So we have mapped out for us a strategic plan for the future. Now it is up to all us, members of GSM, to make it work. That is the key to success in any organisation –a strategic plan and willing hands to carry it out. Otherwise it would just be NATO- No Action Talk Only. We have to be prepared to put in the hard work necessary to change it to Now Action Talk Over!

Every activity of GSM is run by volunteers. We only see and enjoy the end-product but seldom the efforts and sacrifices put in by these brave souls. Instead of thanking and encouraging them we see only their faults and failings and criticise them. Criticisms are welcome if they are constructive and help to improve the Society and should be focussed on the issue and not be personal. I want to foster a culture whereby contributions are acknowledged and appreciated so that people would continue to find it worthwhile to gladly continue serving the Society. When disagreements arise, I want members to try and solve the problems amicably and then move on.

So where is the Society heading? My perception is that the Society is at a cross-road of sorts. On the one hand, we are quite comfortable running our staple activities like the Annual Geological Conference, Petroleum Geology Conference, technical talks, publications etc. etc. The alarming thing is attendance in some of these activities like the technical talks and AGC has been declining. Not many new members have signed up despite more graduates are coming out of the increased number of geoscience programs and departments in the country. We are also no longer the only ones organising geological related events in the country but various other NGOs and commercial conference organisers have started to do so as well. We can feel threatened by their presence or we can welcome and cooperate with some of them because they fit within our mission to promote geoscience.

I would like to end by reminding ourselves of our vision *to be a leader in the promotion of geosciences* and our mission *to promote the advancement of the geosciences and enhance the professional well-being of its members.*

When we do what we are supposed to do and do it well, the membership would increase because they can see the benefits of joining the Society. The branding of our Society will also improve through our promotional activities to demonstrate the relevance of geology to everyday life in the media and at public forums. I am personally interested in trying to upgrade our Society's Bulletin to an Institute of Scientific Information (ISI) journal that would require we produce three years of the publications on time at the frequency stated as one of its requirements. I would also like to take up the suggestion that we make use of cheap regional airfares to expand our activities beyond our shores. For example, we can organise a field trip to Bandung to visit volcanoes and Solo to study its rich mammalian fossil sites and maybe end the trip by travelling to Jogjakarta before flying back to KLIA. The success and growth of the Society is in all our hands and not just the Council. We need all the support you can give us.

3.0) Society Structure

The Society stakeholders are the members of the Society. The Society was operated by the elected Council. The Council main functions were to set directions to promote the advancement of geosciences, endorse the society activities and provide guidance to the execution of the activities of the Society.

The Council was assisted by the Secretariat, the one and only Ms Anna Lee. The Secretariat assisted the Society in the administration of day-to-day activities of the Council, Working Groups and State Representatives.

The Council was also supported by 10 Working Groups and State Representatives. The Working Groups main function is to promote advancement and exchange of knowledge in specific geosciences areas. The State Representatives main function is to promote geosciences and implement the mission of the Society within geographical area. The Organisation Chart of the Society is presented in Figure 1.

3.1) Working Groups

In March 1987, five (5) Working Groups were set up namely Working Group on Engineering Geology and Hydrogeology, Working Group on Economic Geology, Working Group on Stratigraphy and Sedimentology, Working Group on Structural Geology and Tectonics and Working Group on Petroleum Geology. The Working Group on Environmental Geology was formed in 1996. The Working Group for the Promotion of Geosciences, Working Group on Geophysics and Working Group for Young Geoscientists was formed in 1998, 1999 and 2000 respectively. The Working Group on Website was formally formed in 2003.

3.2.1) Working Group for the Promotion of Geoscience (WGPG)

The WGPG for 2004/2005 was chaired by Nur Iskandar Taib of University of Malaya. The WGPG only managed to organize the Petrographic Competition 2004. The winners for the competition are presented in activities section.

3.2.2) Working Group on Structural Geology & Tectonics (WGSG&T)

The WGSG&T for 2004/2005 was headed by Ibrahim Abdullah of Universiti Kebangsaan Malaysia. The WGSG&T jointly with WGSS is organizing one day seminar on Evolution of the Paleozoic Basin – Eastern Block (Central and Eastern Belt), Peninsular Malaysia on 13th August 2005 at UKM.

3.2.3) Working Group on Stratigraphy and Sedimentology (WGSS)

The WGSS for 2004/2005 was chaired by Che Aziz Ali of Universiti Kebangsaan Malaysia. The WGSS will jointly organize the above seminar with WGSG&T.

3.2.4) Working Group on Engineering Geology and Hydrogeology (WGEH&H)

The WGEH&H for 2004/2005 was chaired by Tan Boon Kong of Universiti Kebangsaan Malaysia. The main annual event organized was the GSM-IEM Joint Forum on Roles of Engineering Geology and Geotechnical Engineering in Construction Works on 21/10/2004. The Working Group also organized numbers of technical talks. WGEH&H will organize their annual GSM-IEM Forum on Engineering Geology and Geotechnics every October.

3.2.5) Working Group on Economic Geology (WGEH)

The WGEH for 2004/2005 was headed by Lau Yin Leong of Ginn-M Corporation Sdn Bhd. The chairman had delivered two (2) lectures on economic geology.

3.2.6) Working Group on Petroleum Geology (WGPetG)

The chairmanship for WGPetG is vacant throughout 2004/2005 due to difficulty to find volunteer to chair this Working Group.

3.2.7) Working Group on Environmental Geology (WGENvG)

The WGENvG was headed by Zakaria Mohammad of Jabatan Mineral dan Geosains. The chairman managed to deliver his chairman lecture on 16/3/2005.

3.2.8) Working Group on Geophysics (WGG)

The WGG for 2004/2005 was chaired by Zuhar Zahir Tuan Harith of Universiti Sains Malaysia. The WGG managed to organize Seminar on Geophysics at ESSET, Bangi where the organising chairman was Abd. Rahim Shamsudin of UKM. WGG also managed to organised several technical talks in collaboration with AAPG-USM Student Chapter. The Working Group also planning to organize two (2) day regional seminar on Engineering and Environmental Geophysics on 21 – 22 October 2005 in Kuala Lumpur.

3.2.9) Working Group on Website (WGW)

The WGW for 2004/2005 was headed by Lim Chee Keong of ENSR Corporation Sdn Bhd. The objective of the website is to serve as platform for networking and promotion of geosciences in the internet. The current space usage of the website stands at 60 megabytes. Webserver.com.my was selected as the web hosting company for gsm.org.my website.

The website is generally written in htm, html and ASP. These files were then uploaded to the server using ftp. The content in the website were separated to 3 categories; i) Static information ii) Dynamic information iii) Dynamic exchange.

The upgrading of the Society website is an ongoing process. The Working Group now is ready to disseminate information virtually. All members are urged to give their email address for faster communication.

3.2.10) Working Group for Young Geoscientists (WGYG)

The WGYG for 2004/2005 was chaired by Mohd Fairuz Isa of Ikram R&D Sdn Bhd. Unfortunately, the Working Group still unable to organize any event to-date.

3.3) Ad-hoc Subcommittee

For 2004/2005, there was one Ad-hoc Subcommittee set up based on the direction by 38th AGM 2004 to form Subcommittee to review Constitution.

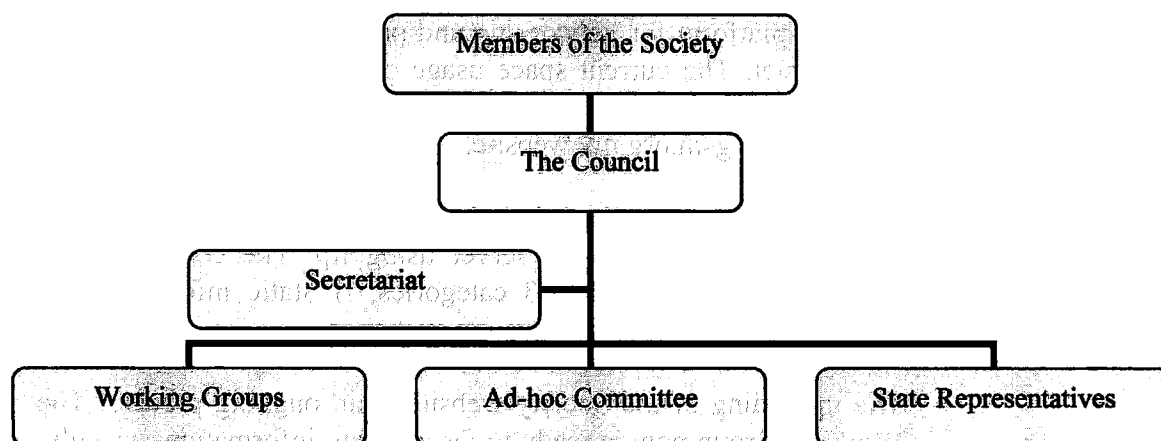

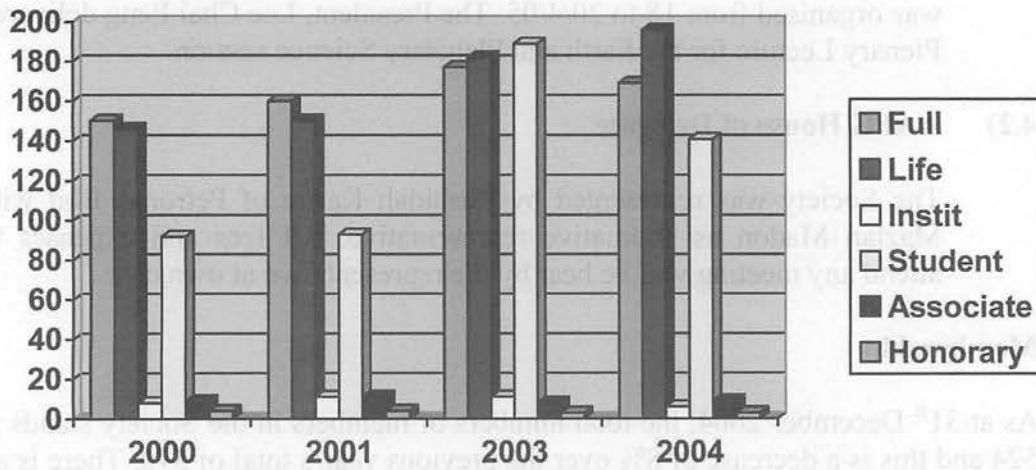


Figure 2: Category of members (2000 – 2004)

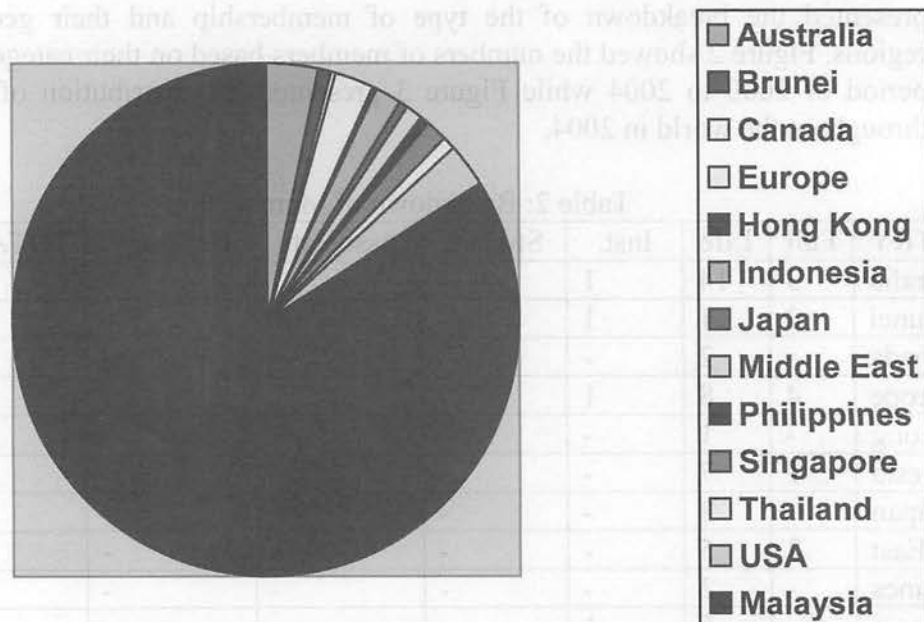


Figure 3: Distribution of member throughout the world for 2004

To help the financially poor final year University students with their theses preparation, a Student Loan Fund was generated after 1973 AGM with an initial allocation of RM10,000.00. Unfortunately, like other loan fund in the country, GSM Loan Fund also suffered from non-performance loan (NPL) repayment. Nevertheless, The Council on its meeting on 8/3/2004 had approved a loan amounting to RM300.00 to one of student from UM

7.3) Best Student Award

In July 1991, GSM Best Student Award (in geology) was offered to eligible final year student from the Department of Geology of University of Malaya and Universiti Kebangsaan Malaysia. The Fund totaled RM2,200.00 comprising an initial donation of RM1,000.00 by N. S. Haile, a similar grant by the Society and RM200.00 by Sawata. For 2004, the GSM Best Student Award receivers were:

- i) John-Mark Anthoa from University of Malaya
- ii) Nobert Simon from Universiti Kebangsaan Malaysia

The Council is planning to extend the Award to Department of Geology, Universiti Sabah Malaysia and Department of Geophysics, Universiti Sains Malaysia.

7.4) Young Geoscientist Award

The Society also recognized good publications by young geoscientists below the age of 30. A Young Geoscientist Award of RM100 was mooted in 1978 and the rules regarding the award finalized in July 1979. Unfortunately, there was no nomination and no winner for the year 2004.

7.5) Geoscientist Award

In 1995, the Geoscientist Award was instituted for a member who did excellent research or a group of members working on the same original research and had contributed significantly to the development of Malaysian geology. Unfortunately, there was no nomination and no winner for 2004.

8.0) Earthquake and Tsunami

The Society was very concern about the earthquake and tsunami happened in this region especially the tsunami struck on 26/12/2004. For that reason, the Society took initiative to organize the following:

8.1) Tsunami Relief Fund

The Vice President and the Secretary on 1/1/2005 had delivered donation from GSM in form of cheque payable to the Malaysian Red Crescent Society amounting to RM2,000.00 at the STAR tower in Petaling Jaya.

8.2) JMG-IGM-GSM Awareness Campaign

The Society jointly with Jabatan Mineral dan Geosains and the Institute of Geology Malaysia has also embarked on Awareness Campaign on Earthquakes and Tsunamis. The Awareness Campaign will be headed by the Vice President, Yunus Abdul Razak and to be conducted in 4 affected states as a start, namely Perlis, Kedah, Pulau Pinang and Perak.

9.0) GEOSEA Status

The current status of GEOSEA was unsettled due to no country interested to continue after the last GEOSEA organised by Indonesia in 2001. The Council took this issue seriously. Society will send letter to the respective countries to register our interest to re-activate and organize the GEOSEA. The next GEOSEA was decided to be organized in 2007. The Council also exploring on setting up permanent secretariat for GEOSEA based in Kuala Lumpur.

10.0) GSM-Student's Geological Club Collaboration

In the absence of provision for Student Chapter in the Society constitution, The Council on 7th meeting on 8/3/2005 agreed to the proposal on collaboration between GSM and student's Geological Club at local universities. The Society will provide assistance in term of administration and financial of a maximum of RM2,000.00 per year for any interested Geological Club in local universities to participate with this programme in order for them to organize any activities suit the Society's objective. In return, the Geological Club must have at least 25 Student Members while the Chairman, the Secretary and the Treasurer of the Geological Club must be a Student Member of the Society.

11.0) Permanent Secretariat

The Department of Geology, University of Malaya agreed to let the Society use a room beside the Department's Library as permanent office of the Society. In return, The Council agreed to the proposal to contribute to the Department for the sum of RM4,000.00 per year for the purpose of upgrading the Library resources. However, the agreement will be on year-to-year basis.

12.0) Acknowledgement

As a final note, the Society would like to extend its utmost appreciation to all the individuals and organizations that have helped in one way or another in the organizing of the Society's activities during this session. Special thank goes to the Head and his staff in the Geology Department, University of Malaya for the use of its premises for most of the Society's meetings and activities, and also the Secretariat; Universiti Kebangsaan Malaysia, Jabatan Mineral Dan Geosains Malaysia, in particular its state office Kedah/Perlis/Pulau Pinang for the AGC 2004, Petronas Bhd and its staff for the PGC&E 2004, and last but not least all members for their advice, guidance and support throughout the year.

For the Financial Year 2004, the society's posted a financial surplus of RM 49,746.00 compare to deficit recorded for Financial Year 2003 at RM 125,596.00. The net current asset has increase from RM 344,517.00 to RM 394,263.00.

Operating revenue was increase from RM166,065.00 to RM 197,187 by 84%. The increased of revenue mainly from Sales of Publications from RM4,915.00 to RM 6,009.00, Petroleum Geology & Exhibition Conference 2004 gain RM 47,406.00 compare from RM 121,702.00 for PGCE 2003 to total net collection of RM 169,108.00 (including balance payment after Dec 2003 for PGEC 2003) and Working Group posted profit of RM 939.00.

Total operating expenditure for Financial Year 2004 was tremendously decreased to RM 147,441.00 compared to RM 291,661.00 for Financial Year 2003. This mainly due to the significant lowering expenses in Printing of Warta Geology from RM81,800.00 to RM 40,955.00, Printing of Buletin from RM 127,193.00 to RM 40,079.00, Annual Geological Conference 2004 from RM 19,622.00 to RM 3,436.00 and postage slightly from RM 10,082.00 to RM 8,602.00.

The Hon.Treasure would like to express a great appreciation to all the donors and sponsor for their contributions and support. Congratulation to Ad-Hoc commitee of Working Groups; Engineering Geology & Hydrogeology, Geophysics, Annual Geology Conference 2004 and PGEC 2003/04 for their affort by implementing wise, profitable budget and contribute to the profitable year .





Notes to the Financial Statements

1. PRINCIPAL OBJECTIVES

The objective of the Society is to promote the advancement of the geological sciences in Malaysia.

2. ACCOUNTING POLICIES

(a) Basic of Accounting

The financial statements have been prepared under the historical cost convention and comply with applicable Approved Accounting Standards issued by the Malaysian Association Standards Board.

(b) Plant and Equipment

Office equipment is stated at historical cost less accumulated depreciation. Depreciation on office equipment is computed on the reducing balance method calculated to write-off the cost of the asset over its estimated useful life at the rate of 10% p.a..

The carrying values of the assets are reviewed for impairment when there is an indication that the assets might be impaired. Impairment is measured by comparing the carrying values of the assets with their recoverable amounts.

An impairment loss is charged to the income and expenditure account immediately, unless the asset is carried at revalued amount. Any impairment loss of a revalued assets is treated as a revaluation decrease to the extent of previously recognised revaluation surplus for the same asset.

Subsequent increase in the recoverable amount of an asset is treated as reversal of the previous impairment loss and is recognised to the extent of the carrying amount of the asset that would have been determined (net of amortisation and depreciation) had no impairment loss been recognised. The reversal is recognised in the income statement immediately, unless the asset is carried at revalued amount.

c) INVENTORIES

Inventories consists of compass and maps valued at the lower of cost and net realizable value.

d) INCOME RECOGNITION

Membership subscription is payable annually at the beginning of the financial year. All subscriptions received during the financial year is recognised as income.

Income from sale of publications is recognised upon delivery of goods.

Income from organising conference is recognised on receipt basis.

Fixed deposit interest income is recognised on an accrual basis.

e) **FINANCIAL INSTRUMENTS**

(i) **Financial risk management objectives and policies**

The Society's financial risk management objectives are ensure that the society creates value and maximises returns to the society and its members at large. The Society has been financing its operations from internally generated funds and therefore is not exposed to interest rate risk arising from bank borrowings.

(ii) **Credit risk**

Credit risk, or the risk of counter parties defaulting is controlled by the ongoing monitoring procedures. The Society also exercised strict control in removing member in arrears in more than six months as provided under the Society's constitution and by-laws.

(iii) **Liquidity risk**

The Society practises prudent liquidity management to minimise the mismatch of financial assets and liabilities and to maintain sufficient levels of cash and cash equivalents to meet its working capital requirement.

(iv) **Fair value**

The carrying amounts of cash and cash equivalents, inventories and payables approximate their fair values due to the relatively short term nature of these financial instruments.

Article III: MEMBERSHIP

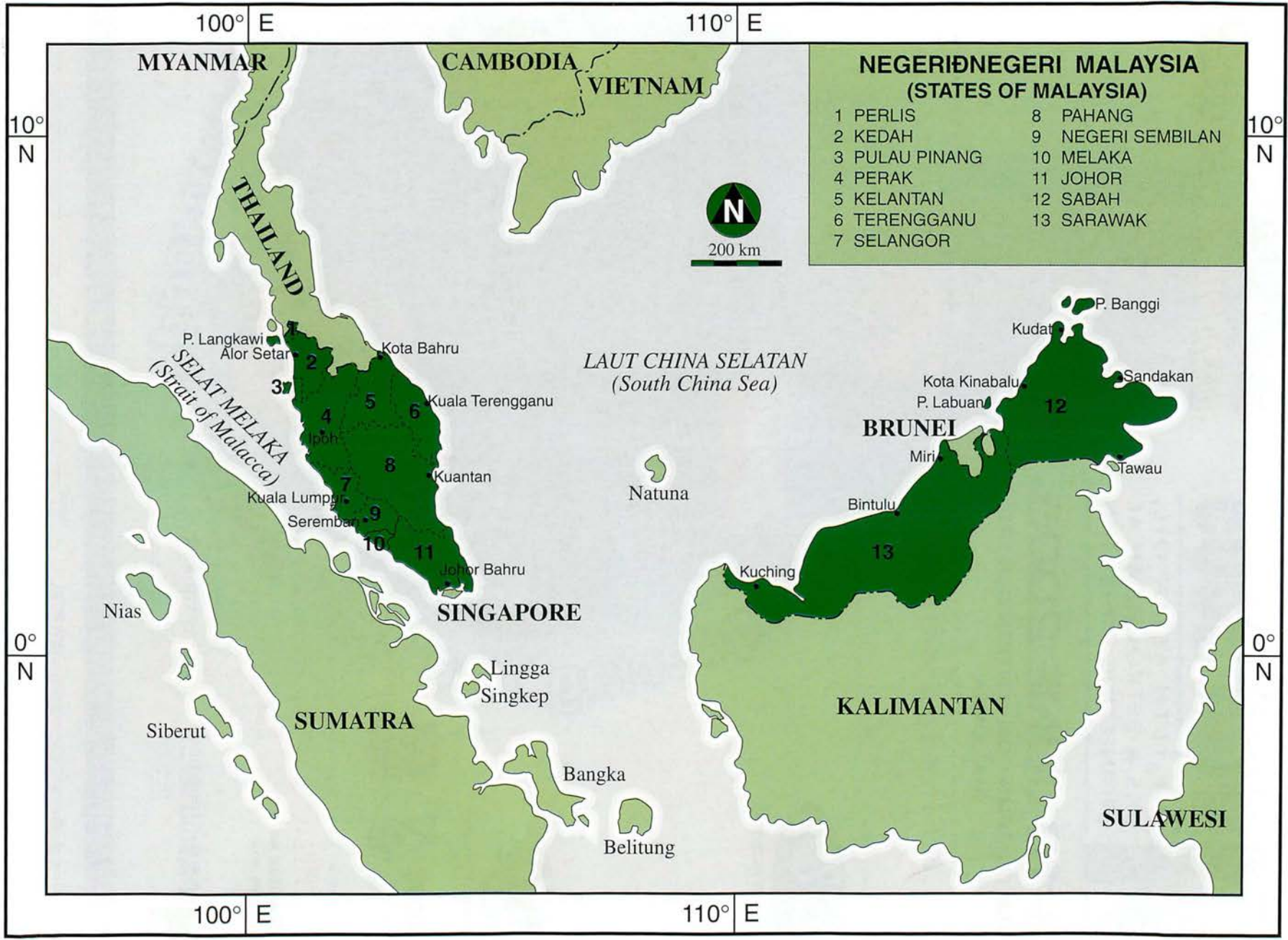
